Part I, Line 10 and Part III, Line 28: The Mountain Endowment Fund, Inc. had held its assets in equities since its inception until the supported organization needed funds to make-up for a shortfall in revenues. These equities were liquidated over time, and the funds were loaned for the purpose of continuing the capacity for operating revenue producing activities, such as programs and program staff.

By 2010 it was evident that the effects of an adverse economic situation could not be overcome, and the loan interest could not be paid.

The loans were forgiven and taken off the books.

Part V, Line 42A This 2010 return has been prepared by the current treasurer on October 29, 2014, in response to a compliance check request dated September 15, 2014.
