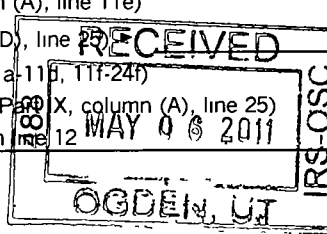

Women's Health, Nursing School Support, and Research Activities in Leogane, Haiti.
The Leogane clinic opened in January of 2009. The new facility supports FHM's
cervical cancer prevention program which provides HPV screening and treatment. The
clinic has screened over 11,000 women since inception. Leogane is home to the FHM
women's group, nursing scholarship program, "peer ally" stress reduction program
and the many student and faculty projects associated with Duke University and
the University of Florida. FHM's long-term plan is to build the Leogane Family Health Center
which will eventually provide comprehensive in-patient and out-patient services for
women and children.

School Education and Nutrition Services in Fondwa, Haiti. FHM supports
the Sainte Antoine School and orphanage program. The school provides education for
550 students in pre-school through high school. Funds go towards teacher salaries,
school supplies, generator operation/maintenance, nutrition, and support of
50 children who attend Sainte Antoine School, and live in the Fatima House Orphanage.
FHM does yearly nutrition assessments and provides anti-parasitic medication and
vitamins, as well as supports an infant/toddler clinic-based nutrition program.

The clinic now has two physicians and a total staff of 17 people including nurses, a pharmacist, public health workers, and office administrators. The clinic provides care to approximately 350 patients each month in the general health clinic and another 60 patients are seen in the cervical cancer prevention program. The Spiritual Support program operates through the Christian Community Church and provides Bibles, pastor salaries, seminary scholarships, Vacation Bible School, pastor's discretionary funds, and a prayer team.

Pt VI-A, Line 2 Board of Director's Secretary, Nancy Holton, is married to Jesse Holton, Financial Officer.
