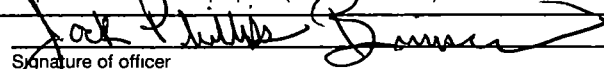

The good news of the gospel of Jesus Christ is always given freely in both English and Spanish during the initial welcome of our honored guests. Every volunteer strives to extend the love of Jesus Christ throughout the visit of each and every honored guest that we serve.

With Love From Jesus Ministries is continually reviewing our operations and expenditures in order to keep our administrative costs as low as possible so that we can focus on our ministry goal of providing for the physical and spiritual needs of those in our community. Through the approval of the ministry's Board of Directors, the ministry has added to our employee base this calendar year in order to provide the most effective and efficient means of delivering these critical services to the public. Compensation for our employees is annually reviewed against that for similar organizations to help ensure that our costs in this area bring only credit to Him that we serve. Our commitment to integrity and transparency is seen through our membership in the Evangelical Council for Financial Accountability (ECFA) and information on our costs can be viewed at their web site at www.ECFA.org by doing a search on our corporate name.

With Love From Jesus Ministries operates out of approximately 20,000 square feet of an old and gutted grocery store. We have lights and electricity, but we have no heating or air conditioning. Without heat and air conditioning, the concrete floors and no window ventilation causes some sacrificial challenges for our volunteers and staff. However, we are blessed through the service done in His name.
