the successful training and education of over 100 women in both the urban informal settlements and rural areas of western Kenya
The training included basic health and nutrition, rights awareness education, leadership building, bookkeeping, and business skills
Activities also included the construction of a commercial chicken coop for a cooperative of 25 women and proper training to
give them a new form of business and income. This chicken project was done in cooperation with a local NGO.

Pangea's School Sponsorship programs achievements for the 2010 were the continuation of school for 7 children who had been
orphaned in Kenya. This program provides the funding for these children to continue school at a boarding school where they have
proper beds, meals, shelter and education. Education is the key to a healthy and strong community and studies show that
for every year a child continues schooling, they delay marriage, reduce the rate of HIV infection and are able to contribute more
positively to their community. Pangea also provides for necessary purchases of school uniforms, shoes, books, soap, etc.

U.S. Education Program achievements for 2010 were continued visits to local high schools and community organizations
to give talks on life in Africa / Middle East and to increase awareness and also continuing work on a collection of women's stories
