

Part III, Organization's Primary Exempt Purpose: The Belt Volunteer Ambulance Service is a public charity formed to provide no-cost or low-cost pre-hospital emergency care and emergency ambulance transportation for residents of Belt and Eastern Cascade County, Montana.

2010 Achievements: During 2010 The Belt Volunteer Ambulance Service provided emergency medical services to 107 patients during ambulance calls. All services were provided by volunteer EMT's who received no compensation for their services. The service acquired an additional ambulance for backup use, outfitted and equipped it, and placed it in service. Members also taught a EMT basic certification class to bring new members into the organization. Due to rising costs from increased level of care, the Service began billing this year with all income applied to supporting operations. With the need for more security for ambulances, supplies and equipment, the Service has acquired a building lot through donation and is planning construction of a building.
