JRF scholars come from diverse backgrounds, but they are united in their dedication and motivation to change their lives.

To be eligible, applicants must be women ages 35 and older, U.S. citizens, enrolled in an accredited school and low income by U.S. Dept. of Labor low income standards. (Continued on Schedule O)

Award recipients are selected annually from hundreds of applications in a competitive, three-tier review process. Scholar selection is organized by staff and carried out by about 200 community volunteers.

Three full-time and one part-time staff manage the national organization with the help of volunteers and interns who assist with daily operations, special projects and events.

Most JRF scholars are heads of their households (85% of 2010 scholars), and more than half (53% in 2010) are first in their families to go to college. Despite the challenges faced by these groups and nontraditional students in general, JRF scholars are succeeding.

According to the annual scholar update survey, 92% of 2010 respondents have graduated or are still enrolled in classes.

The full value of a college education cannot be quantified, but when you look at the median salary for women based on degree, it's clear that education makes a huge impact in earning potential: \$27,404 for a high school graduate; \$32,604 with an Associate's Degree; and \$46,020 with a Bachelor's Degree (according to the U.S. Bureau of Labor Statistics and Census Bureau based on the first quarter of 2009).

JRF scholarships help women achieve financial independence, better provide for their families and make a difference in their communities.
