The Foundation is the leading organization for awarding scholarships to students and risk professionals. Since 1980, the Foundation has awarded nearly \$4.2M in scholarships, with \$150K in scholarships being granted in 2010. FM Global Course Development Grants totaling \$50K was awarded to Ball State University with \$50K for the development of undergraduate course. The RIMS ERM grant of \$50K was used to create professional development programs that enable risk managers to perform more effectively in the workplace and to add value in their organizations. The focus of the programs developed was having risk professionals acquire the necessary knowledge, skills, and tools in enterprise risk management.

Student involvement programs: This program is designed to provide students with a meaningful internship experience and maximum exposure to risk management and the issues facing today's practitioners.
