CFM is constructing a clinic to serve as a free medical mission to serve the people of the Congo river who have no other access to medical help.**

**Outpost Centers International grants funds to Riverside Farm which is located near Kafue, Zambia. Riverside operates a free health clinic that serves an area home to some seven thousand people who have little other access to medical help. It offers four adult training programs: gardening and farming, needle craft and sewing, preventive health and disease treatment, and Bible doctrine, evangelism, speaking and leadership training.**

**Outpost Centers International grants funds to Kidbidula Farm Institute in Mafinga, Iringa, and Tanzania. Additionally, tooth extractions and pregnancy consultations are provided as a service to the local population. Kidbidula Farm began in 1969.**
