4a	Research & Evidenced based Policy Formation - the goal of this program area is to not only influence, introduce and change local, state and federal policies in ways that support CED, it it also to elevate the profile of this organization, our constituents and the CED industry overall. Lastly, this program area seeks also to increase the use of data in appropriately applying CED strategies to address local needs. As such, NCACDC was able to achieve the following outcomes in this program area in 2010: 1) NCACDC affiliate received favorable decision regarding zoning change application, 2) Local ordinance passed which allowed for greater density in housing development, 3) Research, its findings, our affiliate and NCACDC named in several news articles, 4) Issues identified in research subject of national grant awarded to local jurisdiction, NCACDC appearance on televised feature programming, 5) Affiliate adopted practice of using employment mapping as a means to determine potential placement of future housing. Professional Development and Training - the goal of this program area is to become a recognized leader in providing professional development opportunities and enhancement of core competencies for CED practitioners. Additionally, NCACDC seeks to offset cost by soliciting training fees and/or sponsorships. To that end, NCACDC was able to achieve the following outcomes in 2010: 1) provided more than 160 contact hours of training, 2) More than 229 individuals trained, 3) Garnered financial support of other intermediaries and investors in providing scholarships to training participants, 4) Sought to provide training to groups 22 organizations in eastern, NC, 5) Received over \$8,000 in training registration fees. Conference and Summits - the goal of this program area is to lead the industry by introducing the newest, innovative strategies, opportunities, and technologies available while also showcasing its usefulness in responding, assisting and/or carrying out the service delivery objectives of potential partnering groups. Lastly, NCACDC utilizes this programmatic area as a means of soliciting financial support of an array of investors, partners, and friends. In 2010, NCACDC was able to achieve the following outcomes as a result of this programmatic focus: 1) Offered the 1st comprehensive CED conference on Sustainability CED in the southeast, 2) Led as well as garnered the support and partnership of broad array of co-sponsors, 3) Influenced a number of its members, both intermediary and CDC members, to move towards more sustainable development, 4) Attracted new federal agency partner (USDA), 5) Secured over \$30,000 in contributions and registration fees in 2010, and potential of of \$25,000 in 2011 tied to this subject matter.
