The Organization held subsidized seminars and workshops on non-profit management and governance topics. They had their annual conference with 28 sessions and 140 attendees, and at least 42 other workshops attended by over 500 participants. They also held 2 mini-conferences with 9 sessions each with 128 attendees participated.

The Organization engaged in community building and networking, promoting non-profit collaboration, building membership networks and relations, local visits with members and other non-profits, participation in local community, state-wide and national meetings. The Organization introduced thru a pilot program on the gulf coast the non-profit standards for operational excellence program “Excellence in Action (EIA)” The Organization completed the Technical Resource and Networking Services for Faith and Community based organizations in rural Mississippi to provide interim technical assistance and grants to 60 organizations. The Organization successfully completed the MS Delta Empowering Youth Program to provide technical assistance to 20 organizations serving youth in the Delta. They began a two-day “Completing the 501(c)(3) The Right Way” workshop where clients are able to leave with completed paper work which is ready to file with the IRS.

The Organization provided member benefit and advocacy programs, including subscriptions to Non-Profit World for 365 member organizations, negotiating discounts, and providing programs in insurance, pro-bono legal services, and other various issues affecting non-profit organizations. They also provided informational, referral and technical assistance services including maintaining a MS non-profit database with over 11,600 records, resource library, website, newsletters, mailings, telephone assistance, consulting and workshop contracts.
