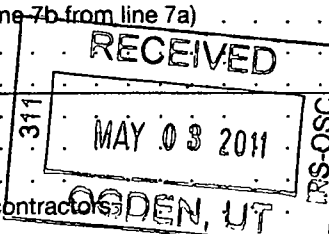




## **A BRIEF REPORT OF THE MINISTRIES OF KERALA CHRISTIN MISSION-2010**

2010 has witnessed the expansion of our church ministries in 4 South Indian States. The ministry in Andhra Pradesh has multiplied to 10 congregations. We have purchased property and dedicated a building in Hiramandalam where over 200 people meet to break bread each Lords day.

In Kerala 27 churches are self supported and a new church building was dedicated at Changanachery Town where over 250 people break bread each Lord's Day.

220 precious souls were added to the Lord's Church during the year as a result of the combined ministries of KCM.

Leaders are being trained in the self supported congregations and preachers meet regularly at Kottayam for on going training.

The orphanage and Old age home continues to serve those in need and Silvia has graduated from nursing college as a registered nurse.

Silvia, Pushpa and Mercy are all grown up and marriage proposals are coming from the parents of eligible bachelors.

The Hospital continues to minister to the sick and the out patient number has increased to an average of 125 per day.

A new ultrasound scan unit was purchased for the New Diagnostic center at Kottayam Town.

A new Mammogram unit was purchased for the hospital and these departments are serving the poor.

The congregation in Dubai is still meeting in a house and online preaching is done from Kottayam on Fridays using Skype. This congregation is supporting a preacher in Andhra.

The Doha congregation is growing and has decided to support a preacher in Andhra.

Our New York ministry is having financial difficulties due to the recession and Orchard group withdrawing the support. Yet the Lord is Good and is providing for it.

We did not have any visiting professors from Seminary of the Nations during 2010.

The family Camp and youth camp were conducted at Vagamon Retreat center and both were well attended.

The Serenity Social Welfare Center is caring for underprivileged students proving meals and free tuition along with moral teachings based on the Bible.

The Children's ministry is headed by Cindy Rajan Martin and Youth ministry by Martin Joseph.

A magazine named 'The Spring' is published by the youth.

My family has grown with the addition of the 5<sup>th</sup> grand child.

The Lord is blessing the ministry and the family. Many families are blessed through KCM.

28 families were given Housing Aid with the assistance from IDES.

Medical Aid was given to thousands of people through the Hospital.

Poor Aid and Marriage aid was given to deserving families.

All these were made possible because of the gracious gifts given to us by KCM Inc.

We praise God for all the donors and pray that God will continue to bless all of you.
