The Southeastern Regional Genetics Group, Inc., held its annual
meeting July 22-24, 2010, at the Sawgrass Marriott Hotel in Ponte
Vedra Beach, FL. Approximately 141 healthcare professionals with an interest
in Genetics attended. Thirty-five platform and fourteen poster
presentations were made covering current issues in all areas of
genetics: molecular genetics, cytogenetics, biochemical genetics,
and clinical genetics. Highlights included genetic evaluation
of short stature, issues in Navajo populations, cytogenetic arrays
in clinical practice, and the importance of standardization of

Key healthcare providers in the SERGG region (Alabama, Florida,

occasions to continue the work begun in 2004. This included addi-
tional training for the telecommunications infrastructure as well
as addressing gaps in education for metabolic nutritionists.
A workgroup of the newborn screening laboratory directors and
follow-up managers continued to address the inconsistencies in the
reporting levels of laboratory results and false-positive rates on
newborn screening tests. This workgroup continues a sample exchange
program for self-testing.
