


Property Management: ACT managed four major preserves with public access, and several smaller conservation properties. ACT's land management includes forest and groundcover restoration, prescribed fire, exotics control, and maintaining public trails. ACT benefitted from workforce funding that provided extra staff for these activities.

4b (Code) (Expenses \$ **92,526** including grants of \$) (Revenue \$)

Acquisitions: ACT added 75 acres to Tusawilla Preserve through a purchase funded largely with funds from the US Fish & Wildlife Service. The Preserve is now almost 600 acres, and protects significant waterfowl and migratory bird habitat, while adding significant scenic frontage along the federally designated Old Florida Heritage Highway. ACT worked on several other land acquisitions in cooperation with the City of Gainesville, Alachua County, Florida Communities Trust, and Federal agencies.

4c (Code) (Expenses \$ **38,301** including grants of \$) (Revenue \$)

Education and Outreach: ACT conducted more than a dozen environmental education classes and public concerts. The Prairie Creek Lodge had dozens of special events, many of which were conducted in partnership with non-profits and government agencies. ACT sent out newsletters, maintained a website, and has an active presence in social media.

the interest in these endowments can be used for monitoring and the principal may be used for enforcement.

Some allow the Corporation to conduct research and studies on the properties. Since the Corporation does not receive any rights to the property, the Corporation assigns only a nominal value of \$1 per acre."
