The Association's Board of Directors represents the group in its initiatives, which are primarily focused on marketing the town through advertising and promotional events and holds its meetings monthly. The general membership also meets on a bi-monthly basis. The Association has developed an annual marketing plan, which measures on a quarterly basis its effectiveness, and markets the town utilizing a broad range of media including print, radio, TV and the internet. Additionally, the MDVMB is also responsible for facilitating three of the town's major events, including the annual Spring Antiques, Collectibles & Crafts Show & October nationally ranked Craft Fair.
