two bedroom apartment. The Deland facility has 4 one bedroom and 3 two bedroom
apartments. Our thrift store receives enough household donations
to furnish all 32 apartments. Residents also receive complimentary
referrals for clothing needs at the thrift store. During 2010 69
residents received training, counseling, emergency medical and dental, and
transportation to work. 38 children were provided with daycare and after
