**Ecovillage Training Center: In conjunction with the United Nations Institute for Training and Research (UNITAR), Global Ecovillage Network and Gaia University, the Institute educates international students and transfers technologies through an immersion pedagogy of ecovillage living, classroom activity and hands-on skill-building exercises, together with workshops, lectures, practical demonstrations, publications, and outreach on six continents. In 2010 GVI provided more than 20 public lectures and 8 extended workshops, and produced numerous publications, including Green Living Journal, course workbooks in several languages and a book, The Biochar Solution: Carbon Farming and Climate Change.**

**Ecovillage Network: GVI is building grassroots movements for ecologically responsible human community having social, economic & ecological sustainability. Global Village Institute is the parent organization for the Ecovillage Network of the Americas and has been a regional office for the Global Ecovillage Network.**

**The Marda Permaculture Farm was originally created in 1990 near the town of Nablus in the West Bank of Israel/Palestine. Global Village Institute, which was active in the creation of the Green Kibbutz Movement in Israel, now has an office and bank account in Nablus and provides workshops, apprenticeships in food production and natural building, and other sustainable-community-building initiatives.**
