MEMPHIS MEDICAL CENTER AIR AMBULANCE SERVICES, INC., THE "WING", IS A NON-PROFIT AIR MEDICAL TRANSPORT WHICH PROVIDES INTER-HOSPITAL TRANSFERS AS WELL AS EMERGENCY SCENE CALLS WITHIN 150 MILE RADIUS OF MEMPHIS. THIS AREA INCLUDES WEST TENNESSEE, ARKANSAS, MISSISSIPPI, MISSOURI, ALABAMA, AND KENTUCKY. HOSPITAL WING OWNS FIVE HELICOPTERS EQUIPPED TO TRANSPORT CRITICALLY ILL AND INJURED PATIENTS. THREE HELICOPTERS ARE STAFFED 24 HOURS A DAY, SEVEN DAYS A WEEK AND ONE HELICOPTER IS AVAILABLE FOR PEDILITE. THE WING TRANSPORTS AN AVERAGE OF 171 PATIENTS PER MONTH WITH 60% OF THESE BEING TRAUMA-RELATED. SCENE FLIGHTS ACCOUNT FOR APPROXIMATELY 35% OF THESE TRANSPORTS. DURING 2010, 2,049 PATIENTS WERE TRANSPORTED IN CONJUNCTION WITH THEIR MISSION AND CHARITABLE EFFORTS, THE WING ANNUALLY PROVIDES CHARITY CARE TO PATIENTS WHO HAVE DEMONSTRATED AN INABILITY TO PAY. IN 2010, THE HOSPITAL WING PROVISION FOR BAD DEBT WAS OVER \$5 MILLION WITH A SIGNIFICANT PORTION ATTRIBUTABLE TO CHARITY CARE. MANAGEMENT ESTIMATES CHARITY CARE TO BE APPROXIMATELY TWO THIRDS OF BAD DEBT EXPENSE. FOR 2010 CURRENT PROJECTS UNDER CONSTRUCTION INCLUDE A HELICOPTER WITH RELATED EQUIPMENT AND A FLIGHT SIMULATOR.
