The Company was selected to participate in the IRS' Compliance Assurance Program ("CAP") beginning with the 2010 tax year. As a result of the Company's participation in CAP, management expects to close all open federal tax years from 2007 through 2010 within the 2011 calendar year. The Company remains under examination for income and non-income tax filings in various state and local jurisdictions for tax years from 2006 through current filings.
