In 2010, the agency provided a loving, Christian home to more than 87 abandoned, abused, and orphaned children from the city of Cochabamba, Bolivia. Fourteen young men and women who grew up at La Villa are attending the University which is an incredible number in a country where less than 10% of the population has a University degree. The agency collaborated with 12 communities in the Andes to provide health care, economic development, agriculture, and water programs to more than 2,200 indigenous people. As a result, childhood malnutrition decreased from 100% to 0%, child mortality decreased from 35% to less than 2%, and 100% of the communities we serve have access to preventative and emergency health care.
