The neighborhood Master Plan will potentially have a direct effect on the 3,000 residents living in the midtown community. A partnership was established with another non-profit housing developer to initiate a plan to develop 54 units in the neighborhood.

In addition, Little Samaritan is providing afterschool services to 8 children enrolled in the McWillie Montessori school program. While enrollment opportunities are open for all families, preference is given for those living in the Midtown community.

On Monday, the students return the backpacks to the program in preparation for restocking and distribution on the following Friday. The "Backpack Buddy" program is currently serving 40 students. Expenses \$ 12,809. including grants of \$ 0. Revenue \$ 0.
