THIS INCLUDES REGULAR MONTHLY DISTRIBUTIONS TO APPROXIMATELY 421 QUALIFIED LOW-INCOME INDIVIDUALS & FAMILIES AS WELL AS EMERGENCY FOOD ON A CASE-BY-CASE BASIS.
