Disaster Relief - On Tuesday, January 12, 2010, Haiti was shaken by a 7.0-magnitude earthquake that killed more than 220,000 people and left 1.5 million survivors suddenly homeless. In response, Cross immediately airlifted 50,000 lbs of food and medical supplies into Port-au-Prince and routed thousands of pounds of food already in Haiti to areas needing emergency relief. With banks and Western Union initially closed, Cross brought in emergency cash by private plane and provided immediate cash to Haitian ministry partners so they could purchase food, medicines, and other urgently-needed supplies while they were still locally available. Cross set up a staging area in Port-au-Prince and delivered food, water, and medicines to ministry partners in the region. Cross shipped \$40 million in medical supplies and a mobile clinic to a hospital in Saint-Marc, and supported the work of a tent hospital in Port-au-Prince. Cross shipped \$400,000 in donated food, medicine, tarps, wheelchairs, crutches, and other much-needed items to refugees in the south of Haiti, and provided food, tarps, and other life-sustaining supplies to refugees in Les Cayes, Leogane, Petionville, and outside Port-au-Prince.

General Support - Cross International is uniquely positioned to help overseas ministries with their specific or unexpected needs. In 2010, these targeted responses helped nearly 50 programs in 14 countries - Afghanistan, Bolivia, the Dominican Republic, Ecuador, Guatemala, Guyana, Haiti, Honduras, Malawi, Nicaragua, Peru, Philippines, St. Martin/St. Maarten, and Zambia. In each of these cases, a mission partner was able to obtain a specific resource quickly and effectively, allowing them to continue their work without disruption.

4c (Code) (Expenses \$ 5,151,391 including grants of \$ 5,151,391) (Revenue \$)

Focus on Medical - Cross International's medical aid focused on needs in nine countries - Afghanistan, Dominican Republic, Guatemala, Haiti, Honduras, Liberia, Philippines, Vietnam and Zambia. This outreach has had a wide-ranging impact. For example, a pediatric hospital was supported in the Dominican Republic, which provides extremely poor families with the only opportunity they have to overcome the disabilities of their handicapped children. In another case, home-based medical care was provided to the chronically ill in an impoverished area of Zambia. If it were not for the care they received, many patients would have left their children needlessly orphaned. Providing medicines, equipment and grants to these and other Christian medical projects is even more valuable when it makes effective use of facilities and staff members already in place. Some facilities would have been abandoned without this aid, and their staff members would have been jobless. By equipping them with resources necessary to provide services to their communities, Cross helps thousands of families who would have had no other option for quality medical care.

as family groups, whenever possible - in the homes of volunteers who provide parental care Funding by Cross has enabled the programs to shelter thousands of otherwise homeless children and to supply the host families with food, medical care and other resources Other programs funded in 2010 include traditional orphanages in Guatemala, Guyana, Haiti, Malawi and Nicaragua, and outreaches in Bolivia and Ecuador closely linked to schools that provide at-risk street children and orphans with a safe environment to learn 4d Additional Program Services - Focus on Food Fighting malnutrition is a priority for Cross International and the organization sponsored significant programs in 13 countries in 2010 as part of this mission Countries included Afghanistan, Bolivia, Dominican Republic, Guatemala, Haiti, Honduras, Liberia, Nicaragua, Peru, the Philippines, St Martin/St Maarten, the U S and Zimbabwe In all, more than 42 individual in-country partners were involved in the distribution of hundreds of thousands of Cross-sponsored meals throughout the year, including 16 earthquake-relief outreaches in Haiti Hunger and eventual malnutrition cause both physical and mental disabilities in children, so many food shipments were specifically earmarked for distribution to infants, toddlers and adolescents The impact of this focus was enhanced by using schools for poor children as a network for distribution This not only produced a decrease in malnutrition and related medical disabilities in the areas targeted, but it also improved school performance among those children who were fed Other unique projects included a major feeding program for street children in Bolivia, a project targeting hunger among families and the elderly in the Dominican Republic, and a campaign to supply 1 million meals worldwide in the form of "Vitafood" - pre-packaged nutritional meals that are easy to cook and serve 4d Additional Program Services - Education Cross International's educational programs targeted needs in eight countries Afghanistan, Bolivia, Dominican Republic, Ecuador, Guatemala, Haiti, Honduras and the Philippines Although educational opportunities are technically offered by the governments in many of these countries, there are many practical problems with this service In some cases, the government schools are substandard In other cases, there are requirements that prohibit attendance by the poor - small tuition fees are still too high for parents to pay, requirements that supplies be purchased by parents cannot be met, and dress codes that include shoes or uniforms are beyond the means of some families Cross has supplied a quality education to thousands of children in these positions by partnering with church-run schools that will accept such students and supply them with the materials and resources they need Some of the specific projects Cross funded in 2010 also included tutoring programs aimed at supplementing the work of government schools These outreaches not only provide educational services, but they also serve as refuges for children living in hostile or violent conditions 4d Additional Program Services - Water Projects Cross International funded large-scale water projects in Vietnam and Zambia in 2010, establishing 43 wells and 50 water filtering systems in remote areas Since water is crucial for both human consumption and support of agricultural/livestock projects, the organization targets both needs The effort to provide safe drinking water typically involves comprehensive efforts that serve thousands of individuals in several surrounding communities For example, Cross funded a water project that involved not only drilling wells in eight rural villages of Zambia, but also training the communities in sanitary hygiene practices and protecting the water table through construction of latrines In areas where water projects are established the impact is immediate and dramatic Water-borne diseases transmitted by unsafe water are a leading cause of death among the poor, particularly infants and young children Supplying safe water produces a significant drop in infant mortality rates related to these diseases By establishing new sources of safe water that can serve communities for years to come, Cross International's 2010 projects will protect thousands of families from illness and save hundreds of lives 4d Additional Program Services - Housing Cross International undertook housing and house-building programs in four countries Guatemala, Haiti, the Philippines and Vietnam These programs had a variety of objectives The program in Guatemala funded a safe house for families escaping domestic violence In Guatemala, the funds were used to construct safe, stable homes for the poorest of the poor In Vietnam, the projects were focused on replacing or repairing severely damaged roofs In Haiti, Cross launched construction projects to provide housing to homeless earthquake survivors 4d Additional Program Services - Self-Help Projects The focus of self-help projects in 2010 was the funding of micro-finance loans in the Philippines, enabling the partner ministry in that country to expand their services to more recipients This program was focused on helping single mothers who struggle to support families Through the loans, they are able to create small, self-sustaining businesses capable of producing enough income to meet their needs for food, medicines, the education of children and other benefits 4d Additional Program Services - Shipping Cross International's shipping program often uses financial donations to transport and distribute donated goods ranging from food and medicines to office/school furniture and sophisticated medical equipment The financial impact is significant because a donation of one dollar can place \$80 or more worth of aid into the hands of the poor or the ministries serving them Other times, Cross buys specific goods on the worldwide market, such as treadle sewing machines for example, and ships them directly to the partners who need them By buying in bulk and buying where the cost is lowest, Cross is able to realize much greater savings than sending cash grants for those ministries to purchase the items themselves In 2010 Cross shipped goods to nine countries Afghanistan, Congo, the Dominican Republic, Guatemala, Haiti, Liberia, Nicaragua, the Philippines, and the U S Medical shipments have been particularly important, delivering life-saving medications to clinics with virtually no supplies Without these medicines, these medical outreaches would have turned thousands of patients away with no treatment The Cross shipments restocked these clinics and provided for the effective treatment of families in the community Shipments of medical supplies as well as food, water, tents, and other aid were invaluable during the aftermath of the earthquake that struck Haiti January 12 4d Additional Program Services - Mission Education Cross International's overall mission includes educating Christians in the United States about the needs of the poor overseas This is important to the organization's goal of developing stronger relationships between America and the underdeveloped countries of the world It is also part of Cross International's effort to support Biblical teachings that highlight God's commands to support the poor and to love one another In 2010, Cross achieved this goal by communicating directly to American Christians through Christian radio A total of 77 day-long and two-day radio presentations were made to the public on radio stations heard in all 50 states Two of those events were broadcast on satellite radio while two were webcast on the Internet to listeners worldwide 4d Additional Program Services - Project Development In order to ensure the proper use of donated funds and commodities, Cross International systematically visits overseas partners In 2010, the Vice President of Missions and four field officers made regular visits to these in-country ministries, reviewing requests for assistance, monitoring the use of previous gifts and providing professional assistance with accounting or project development issues These project development services have helped Cross partners grow more effectively, provide a better outreach to the poor and maintain greater stability in the community
