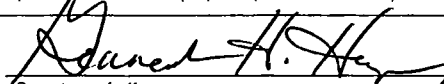

At the present time 2Unique CSF has limited funds to expand our outreach programs. Our staff is in place when the funding becomes available to fund all outreach services. Our directors teach and responsible to manage the area budgets. Financial statements are disclosed via the web site.

Our programs assist teens in enhancing their reading skills with the Teen Book Club. We have an entrepreneurship program active in the Shelby County Division of Corrections.
