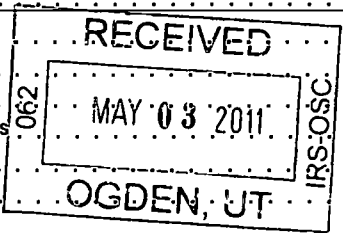



STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

Activities in 2010 focused on three themes – oral health literacy, access to care issues, and education/mentoring. The Santa Fe Group convened a planning meeting in September. During the meeting, the group discussed ways in which they could catalyze positive change within the three key themes previously identified. The JPHD contracted Santa Fe Group to draft an article, DTA contracted SFG to help facilitate the Oral Health Scholars program, and the Maryland State Oral Health Coalition sought partnership in planning their 2011 oral health conference. The group continues to develop the Meskin Fellows Program. Other activities involved assessing the Santa Fe Group brand, building brand awareness, and improving communications through print and electronic media.
