THE EIGHT-WEEK PROGRAM CONSISTS OF SIX "MED CAMP" SESSIONS DEDICATED TO CHILDREN WITH SPECIFIC MEDICAL CONDITIONS OR DISABILITIES, AS WELL AS TWO "KOTA CAMP" SESSIONS WHICH PROVIDE AN INCLUSIVE CAMPING ENVIRONMENT FOR CHILDREN WITH AND WITHOUT DISABILITIES. 357 CAMPERS ATTENDED A TOTAL OF EIGHT CAMPS.
