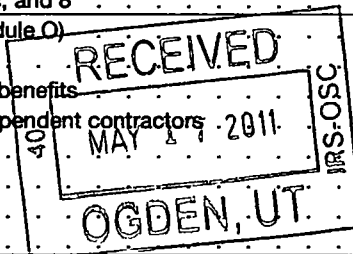

However, missionaries or evangelists that WMT has chosen to sponsor, and who meet the qualifications set forth in the By-Laws,

receive monthly distributions from funds each has personally raised for support while serving as a missionary or evangelist.

Each must submit a budget to be approved by the Board and personally raise funds for his support to be disbursed while serving.

WMT serves as an independent monitor of the funds received and disburses them according to the approved budget.

Rev. Bruce Mumm, Rev. Dennis Thrasher and Rev. Wade Mumm are directors of WMT and received no compensation as such.

They are also Missionaries sponsored by WMT and, as such, receive a monthly distribution based on a Board approved budget.

They each received a form 1099 for funds received as missionaries.

Also, Frankie Crabtree is a Director and the Treasurer of the Board of WMT and she received no compensation serving in these capacities.

Her services were retained for monthly bookkeeping and professional advice, as noted in Board meeting minutes.

She was paid \$6,000 in 2010 for which she received a form 1099.
