 As results are intangible and number of listeners fluctuates, it is impossible to list how many problems are helped or resolved as a direct result of a single broadcast. Listener response is very positive and indicates appreciation for the service provided. Many responses do indicate personal improvement and problems resolved as a direct result of advise/counsel received from broadcasts. Approval of the ministry is apparent since all costs, for operating and otherwise are met by voluntary listener contributions - direct public support.
