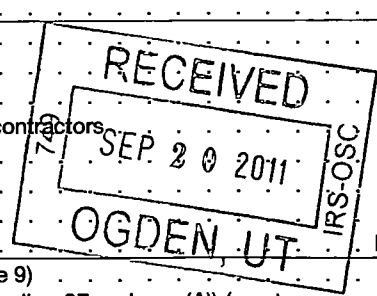

• "Stories From The Faubourg Tremé," about one of America's oldest black neighborhoods, was distributed on DVD and was

broadcast again on many PBS stations and had film fest showings. The film continued to garner interest nationwide.

• "Bury The Hatchet," a documentary about Mardi Gras Indians, went into distribution and was highly praised at film festivals.

• "The Music's Gonna Get You Through" (formerly entitled "See What I'm Saying"), a documentary on Henry Butler (a blind pianist, who

teaches blind musicians in a summer program at the University of New Orleans TRAC center) and the lives of several blind teenagers

over several years, was completed and seen on many PBS stations and in festivals.

• The Human Rights Film Festival, a festival exhibiting films on worldwide human rights issues, occurred in the spring

• "Sons of Tennessee Williams," a documentary on gay civil rights history and issues, in New Orleans, picked up a distributor
