



Exempt Purpose

Our organization acts as a union representing 381 federal employees. We negotiate, solve grievances, monitor employee working conditions, conduct member meetings, and recruit new members. We also provide members membership in Mutual Aid Pledge Society and assistance for grievances if required.

Line 28

We represented 381 federal employees during 2010. Our representational services included negotiating working condition changes (25), negotiating labor agreements (1), representing employees during disciplinary actions (15), and representing employees on partnership forums:

- FAA National Labor Management Forum
- Academy Safety Committee
- MMAC Occupational Health and Safety Committee
- Facility Labor Management Council
- Employee Attitude Survey
- ISO, LLS and Project Management Workgroups

We provided advice and council to numerous employees and promoted the general welfare for all employees during 2010.
