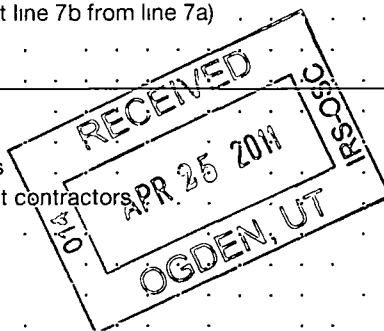

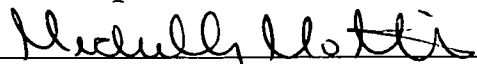

In 2010 the CPSF endowed 3 scholarships. The oldest, Dunnell scholarship has been giving \$500 scholarship each year since proceeds were received. Two of the grants were previously funded by a fundraiser from the annual event silent auction and were subject to change based on the amount raised. By designated assets towards those scholarships, they are no longer subject to a fundraiser and are dedicated to be funding each year in perpetuity. Moving the funds to Communities Foundation of Oklahoma provided a \$5,000 matching grant for each scholarship which is used to help fund those grants annually. We are seeking monies from individuals to name the scholarships and add funds to the principal and ultimately increase the size of the annual scholarship.
