STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

Central Oklahoma United Methodist Retirement Facility, Inc. (DBA Epworth Villa) was incorporated in 1986 as an Oklahoma not-for-profit corporation to provide Resident First Care -- a superior quality of life for older Oklahoma adults by anticipating and meeting their individual physical, emotional and spiritual needs in a Christian environment that adds a richness and excitement to the experience of aging. As the only CARF-CCAC-Accredited and Eagle-Accredited Continuing Care Retirement Community (CCRC) in the State of Oklahoma, Epworth Villa offers apartment and cottage-style residences, traditional assisted living, specialized memory care assisted living and skilled nursing services, serving over 633 residents and patients in 2010, with a wide range of services and amenities, such as a wellness center including an indoor swimming pool, educational and spiritual opportunities, and areas to practice hobbies and interests on a beautiful 40-acre campus located in Northwest Oklahoma City. The community offers both fee-for-service contracts and life care contracts where fees do not increase substantially based on the level of care provided.

In Fiscal Year 2010, Epworth Villa reported more than \$170,000 of costs related to Community Benefits in the following areas:

Charity Care

Multiple residents received financial benefit from the Benevolent Fund in 2010 totaling \$71,793.

Community Health Improvement Services

Epworth Villa continued its' partnership with The Arthritis Foundation to provide a low-impact exercise class for senior adults in the surrounding community with arthritis every Tuesday and Thursday.

Life Line Screenings, a mobile health screening service providing vascular screening services and other preventive health screenings, are hosted once a year at Epworth Villa, serving 100 senior adults in the surrounding community in 2010.

Health Professions Education

In 2010, Epworth Villa's nursing staff spent more than 1,900 hours mentoring nursing RN, LPN and CNA students from the University of Oklahoma, Rose State College, Francis Tuttle VoTech and Metro Technology Center.

Epworth Villa continues to serve as a clinical site for students interested in Wellness, hosting over 200 hours in 2010.

Community Benefit Operations

Epworth Villa employees are encouraged to volunteer throughout the community.

Organizations benefiting in 2010 include: The Edmond Senior Center, Edmond Women's Club, Oklahoma City Rotary Club, Oklahoma City Arts Council, Oklahoma Gerontological Nursing Association, International Facility Management Association, Oklahoma Alliance on Aging and Girl Scouts of Oklahoma. In addition, several staff members gave educational lectures and presentations at various events.

The Epworth Villa Volunteer Program for residents has 122 registered volunteers. In 2010, Epworth Villa Volunteers spent 3,000 hours volunteering in the outside community and 11,750 hours volunteering within the Epworth Villa community.

Epworth Villa serves as a polling place for two voting precincts and provides meeting spaces free of charge to a variety of community organizations including: Girl Scouts, United Methodist Church, church groups, and investment clubs.

Epworth Villa's Alzheimer's Support group meets monthly. These meetings have been taking place since 2008.

The Parkinson Support Group meets monthly. These meetings have been taking place since 2005.

Epworth Villa continued its' partnership with AARP to provide a safe driving class semi-annually for 50 senior adults in the surrounding community.

Cash and In-Kind Contributions to Community Groups

Epworth Villa employees donated more than \$3,200 to the United Way in 2010.

Twenty-three employees and residents raised \$2,380 for the Alzheimer's Association Memory Walk.

In 2010, Epworth Villa hosted 7 omelet breakfast fundraisers for different community organizations. Staff and residents participated in these fundraisers. A total of \$3,187 was collected and donated to different organizations including: The Red Cross, Jesus House, Skyline Urban Ministry, Parkinson's Foundation, American Heart Association, American Cancer Society, and the Alzheimer's Association.

Epworth Villa's Religious Life Community donated miscellaneous medical supplies and collected and donated 69 large bags of clothes for Skyline Urban Ministry.

Epworth Villa sponsors a local Junior Basketball team.

Epworth Villa donated 150 dining room chairs, a television, a floor lamp, and a CD player to the Exodus House. The Exodus House includes apartment complexes where people newly released from prison can live with their families while they re-enter life successfully outside prison walls. Leaders say those who take this route rarely return to prison.

A group of residents, staff, and family members from Epworth Villa spent an afternoon volunteering with the HUGS Project. We spent several hours making care packages for the soldiers. The Hugs Project, sends care packages and other handmade items to the soldiers overseas.

Epworth Villa partnered with the First Christian Church of Oklahoma City to create a Meals On Wheels Program. Our kitchen staff cooks the meals and the church pays \$3 per meal. The program produces 130 meals per month. The cost of each meal is reimbursed, however the staff hours dedicated to this service are not reimbursed financially.

On November 25, 2010, the staff in our kitchen cooked a Thanksgiving meal for our local fire station (#37). This meal fed all 7 firefighters on the shift. Earlier that week residents from our Assisted Living area baked cookies and delivered them to Station #37 as well.
