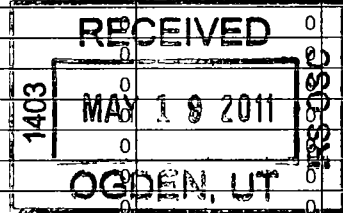

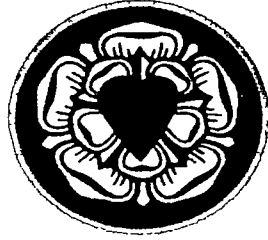

The Allen C. Berndt scholarship grant is available to students graduating from a Lutheran high school of the Lutheran Church - Missouri Synod or in a Recognized Service Organization relationship with the same. One grant will be made available each year in the amount of \$500.00 per school.

The grant is available to students graduating from **Sacramento Lutheran High School** in Sacramento, California, **Martin Luther High School** in Northrop, Minnesota and **Sierra Lutheran High School** in Carson City, Nevada. One scholarship will be awarded to eligible students who apply from each school as determined by the board of directors of the Foundation.

If no seniors are eligible in the afore mentioned schools then teachers or principals are eligible to apply for a grant as mentioned below.

The intention of this scholarship is to highlight the need for pastors in the LC-MS and for teachers in Lutheran schools in the same. Any graduating high school senior is eligible to apply for the scholarship, however, with the following requirements.

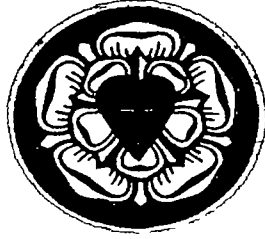

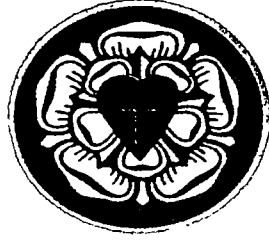

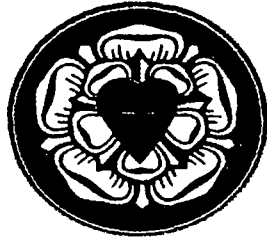
