During 2010, funding was provided to support the implementation of 21st century technology in District classrooms, to support early reading success at the elementary school level, and to assist with the implementation of elementary-level International Baccalaureate programs at two schools. Funding was also provided for backpacks and school supplies for children in need of assistance with these items. At the high school level, funds were provided to assist with transportation of students to a vocational auto shop program in Mancos which Durango High School would not otherwise have been able to offer.
