The compensation representative considers several factors, such as (1)the complexity and diversity of responsibilities of the CEO's position (including licensure, regulation, certification, and operation of the skilled nursing facility), (2)initiatives undertaken, in process, or planned, (3)status and progress of the organization, (4)the Social Security Administration cost of living adjustment, (5)the Association of Jewish Aging Service Compensation Survey, (6)management of multiple lines of business, and (7)the continuous employment agreement between the organization and the CEO. Based upon these factors, a mutually agreeable compensation amount is determined by the compensation representative and the CEO. The compensation representative confers with certain members of the board for approval of the compensation agreement. The organization maintains the appropriate documentation of the process through which the compensation amount was set. This compensation-setting process is done on an annual basis. The organization does not have any other officers or key employees, however, it does have a process to determine reasonable compensation for its employees.
