Operation of a Christian retreat center that hosted and programmed ecumenical
Christian retreats for churches and individuals from various Christian
denominations. In 2010, 37 retreats were held with over 1,600 guests attending.
Nationally known speakers and resource people from across the country were brought
in to help ensure the excellence of these retreats. Financial assistance of \$19,330
allowed individuals and couples in need to attend retreats. Financial assistance
from the Laity Lodge Speakers' Fund covered 81% of speaker honorariums.

Grants to support affiliated organizations in furtherance of mutual visions
around the renewal and transformation of daily life. Grant to Laity Lodge Foundation
allowed 105 youth ages 7-16 to attend a one-week or two-week camp session at a discount
or free of charge based on financial need. In addition, a grant to Laity Lodge Foundation
allowed 200 Haitian children to attend a four day camp at Jacob's
Well Youth Camp in Limbe, Haiti. The grant also provided for the construction
of a water well and other improvements at Jacob's Well. Grants to
the H. E. Butt Foundation Free Camp Program provided funding that
assisted in the operation of facilities that were used by over 250 nonprofit
groups, representing over 22,000 people, at no charge. The Free Camp program

Promotion of lay renewal as a therapeutic force in the church and in society
