CHISHOLM TRAIL COMMUNITIES FOUNDATION (CTCF) IS A TAX EXEMPT, NON-PROFIT, PUBLICLY SUPPORTED, PHILANTHROPIC INSTITUTION WITH THE LONG TERM GOAL OF BUILDING PERMANENT, NAMED FUNDS FOR THE BROAD-BASED CHARITABLE BENEFIT OF THE LOCAL RESIDENTS. THE MISSION OF CTCF IS TO ENHANCE THE QUALITY OF LIFE IN THE LOCAL AREA. CTCF CARRIES OUT THIS VERY BROAD MISSION BY BUILDING UNRESTRICTED FUNDS AND USING THE ANNUAL INCOME TO SUPPORT A VARIETY OF LOCAL NONPROFIT ORGANIZATIONS THROUGH GRANTS AND SPECIAL PROJECTS. CTCF'S ASSETS ARE HELD IN SEPARATE FUNDS ESTABLISHED BY LOCAL INDIVIDUALS, FAMILIES, BUSINESSES, AND CHARITABLE INSTITUTIONS. THE IRS RECOGNIZES CTCF AS A PUBLIC CHARITY IN PART BECAUSE THEY RECEIVE SUPPORT FROM THE GENERAL PUBLIC AND THEIR BOARD BROADLY REPRESENTS THE AREA SERVED.
