Total served in 2010 was 316,042 individuals, 187,531 adults and 128,511 children. DBM supervised 200 volunteers in the packaging of 73,886 Kids Against Hunger meals. The meals DBM prepared were shipped to Haiti 28,512 meals, to the Amazon 14,256 meals, and into Mexico 10,382 meals. The rest were distributed within the U.S.
