Haiti Earthquake Relief : We collected supplies primarily from other agencies and trucked them to Lake Charles LA and later to Miami Florida where the ministry Friendships loaded the products onto their ship and carried them to Haiti for distribution through Haiti One and other local Haitian organizations. In all 8 semi loads of new tents, sleeping bags, rolling duffle bags, rolling ice chests, new Clothing, sleeping matts, Hand crank wheel chairs, MRE's, bottled water, 40,000 pounds of rice, pallet of fresh eggs, medical supplies, toilet paper, generators, new shoes, olive oil, canned foods, soaps hand sanitizer and cleaning supplies were sent.

Distribution of "Gift in Kind" supplies to other agencies. 58 agencies served including 4 food banks, 5 drug & alcohol rehab program 13 Rural ministries, 9 youth programs, 16 church outreaches, 4 ministries at the Mexico border, 7 inner city outreach ministries. Approximately 2,000 families are aided each month.
