After completing project of infrastructure (housing, water, electricity, school) the principal activity of Austin Helps Honduras continues to be support of scholarships for the children of Colonia Solidaridad, the village constructed (beginning in 1999) to relocate flood victims of Hurricane Mitch (1998)

Scholarships are offered to all children of Colonia Solidaridad who need economic assistance for school uniforms, shoes, school supplies and incidental expenses, especially those who are able to attend school beyond the government provided sixth grade. Candidates are screened and recommended by a committee of Honduran agents (Juan Pablo Aguilera and Maria A. Owen) then finally approved by a US committee of sponsors and reapproved each semester only if the students have made passing grades. Also, some economic assistance is provided for a few adults for short-term vocational training.

Other income - line 6a includes monies raised from fund raisers, including book sales, sales of note cards and pancake breakfast.

***No amount was entered into line 1 as there is not support received from a government agency.

The reason Schedule A was not submitted with the original return was because I thought Schedule O replace schedule A as we do not have support from a government unit. I am not able to get support from the IRS center here to help when filling out the form - which is very confusing. I ask that you waive any penalties as we have always filed our return in a timely manner and do not have a large amount of funds to support the children of Honduras.
