The focus of our volunteer work is with children, youth and the elderly. The students visit, entertain, and take gifts to Arnold Palmer Children's Hospital and The House of Hope (a home for troubled teenagers), Shriner Children's Hospital, All Children's Hospital, Head Start Programs, Give Kids the World, Children's Shelters, Senior Citizens Groups at churches, Ronald McDonald House, the Wolfson Children's Hospital, the Daniel residential treatment center for children, the PACE Center for girls, the Taylor Nursing Home, and Memorial Hospital in Jacksonville. A special project each year at Christmas is collecting gifts for the Santa program at the hospitals. We also visit and entertain at Terra Vista Nursing Home, Westminster Towers, the Sterling House Retirement Center, the Taylor Home and the Children's Home Society, and the Veteran's Hospital.
