1 Briefly describe the organization's mission

Mission & Purpose On any given night in the Dallas area, more than 1,100 children will fall asleep in homeless and domestic violence shelters. Of these, 66 percent will be under the age of nine and 31 percent are infants and toddlers under the age 3 years. The Dallas County homeless population has shown a 138 percent increase in homeless households who live in Transitional Housing compared with numbers from 2005. This is just one of the counties that Captain Hopes Kids serves. In 2010, children made up 25% of the homeless in Tarrant county emergency shelters and transitional housing. Fifty percent of the agencies surveyed reported they had to turn away homeless children because they were operating at capacity. The mission of Captain Hope's Kids is to meet the critical needs of homeless children. It is the only agency that actively solicits donations and funds for the sole purpose of providing critically needed supplies to homeless children throughout North Texas. In 2010, Captain Hopes Kid

Programs & Services Lifes Necessities1 For Babies and ToddlersThe increasing number of homeless families with babies creates a sharp rise in the need for diapers, wipes, ointment, formula, baby food and baby toiletries. Because homeless parents are often unable to afford these items, many infants suffer poor health and hygiene. Improper nutrition and the resulting depressed immune system can set the stage for years of poor health. Last year we distributed more than 8707 diapers every week. Captain Hopes Kids provides lifes necessities for the most vulnerable of the homeless - babies and toddlers. 2 For School Age ChildrenA survey of Metroplex shelters revealed that education is a critical long-term need of a homeless child and the key to breaking the cycle of homelessness. Captain Hopes Kids provides basics that homeless children, ages 4 to 17, need to attend and stay in school, including school uniforms, shirts, pants, skirts, shoes, socks, underwear, and school supplies. We accept new and gently used items through individual donations and company-sponsored drives. Homelessness has a devastating impact on homeless childrens educational opportunities. Without basic toiletries, school supplies and clothing, children are less likely to do well in school. Distributing critical items to homeless children allows homeless parents to devote more energy to activities that will help them to break out of homelessness. 3 Recreational Activities ProgramThis program provides opportunities for homeless children to participate in activities with the Dallas Mavericks Texas Rangers. These activities provide opportunities for children to get out of the shelter setting learn more about the world around them and have fun. In 2010, we provided \$35,465 in recreational activities to homeless children. 4 Hope-in-a-BoxThis program provides a simple, gift-wrapped shoebox filled with small gifts, toiletries, and special surprises for homeless children living in a shelter. By volunteering to create these care packages, groups with member of all ages and backgrounds have the opportunity to help other children who are less fortunate.
