

The Plano Wildcat Quarterback Club is a non-profit (501c-3) organization. Our purpose is to "promote the fellowship, good sportsmanship, and school spirit for the Plano Senior High Wildcats Football Team. In addition, to involve parents, students and the community in the tradition-rich, state-renowned, and immensely successful high school football program of Plano Senior High School (PSHS)."

We provide needed equipment and items not provided for by the school district. Examples of equipment and supplies purchased this reporting year include 10 fully equipped weight racks for the weight room, professionally installed stereo system including speakers for the weight room, head sets for the coaches, weight room refurbishing and sanitizing, summer conditioning and training equipment. Expenses also included funding two scholarships for the next 6 years and a banquet at the end of the season.
