One Hundred Ninty One (191) individuals were counseled for a total of 1,721 counseling hours. The donations received directly for this program totaled \$41,971. Allocated expenses totaled \$197,342.

Exchanged Life Ministries Texas offers seminars and workshops on the victorious Christian life. During 2010, Exchanged Life Ministries presented four (4) seminars with 233 attendees. In addition ELMT presented two (2) workshops with 25 attendees. ELMT directly received donations of \$14,184 for this program with allocated expenses totaling \$62,854.
