28 Religion Related, Spiritual Development The SALT Project served the church by facilitating literacy, discipleship and Scripture Impact to transform communities pursuant to Matthew 28 19-20, promoted Theological Education by Extension (TEE), and trained over 100 Pastors and Missionaries in Christian Conciliation. Further, we conducted seven "Scripture Application & Leadership Training" (SALT) courses, training over 1,000 pastors and leaders in PNG. As part of the SALT course outreach, these leaders traveled into the surrounding villages, preaching and teaching the Gospel to over 6,800 villagers in their own "heart-language." Additionally, in 2010, we continued to mentor our Certified SALT Instructors in the SALT Methods and Consultant Skills mentoring program to better equip SALT personnel (1,500 families). The total program service expenses total \$35,333.00, which includes \$18,252.00 in ministry expense reimbursements (MER) paid through an Accountable Reimbursement Plan (APR) to accomplish the exempt purposes of The SALT Project. Also included are grants and allocations of \$8,744.00 to Wycliffe Associates in furtherance of the exempt purposes of The SALT Project.
