These centers are designed specifically for the aid of human trafficking victims. Centers will provide shelter, education, counseling and case management services. Some also offer life enrichment courses, life coaching workshops, outdoor recreational activities, arts and crafts, and mentoring services.

The organization partnered with Mercy Ministries, Inc., a non-profit Christian residential program serving young women between the ages of 13-28 who face life-controlling issues, to share information and resources while raising awareness about domestic sex trafficking with the goal to develop residential shelters with counseling programs for female victims using the Mercy Ministries counseling model. This conference focused on best practices for shelters caring for victims of human trafficking in the United States through funding assistance provided to Christ-centered organizations who meet previously established standards of care.


