The BBHH Community Clinic provides quality health care to adults in the community. The clinic is staffed by volunteer doctors and nurses. Specialized care is available through a partnership with Baylor Health Care System and the Dallas County Medical Society Project Access program. In addition to medical care, the BBHH health program includes diabetes education, free mammograms, flu shots, and nutritional training.

The BBHH food pantry provides food for over 200 families each week. Neighbors come twice a month and receive over 35 pounds of food each time. When coming to the food pantry they also become aware of other opportunities such as educational programs and preventive health care.
