The proof of enrollment must be from the student's university and include their student ID number printed on the document. Once received, the Treasurer sends a request to the Bookkeeper to write a check. The check is written directly to the University and includes the student's student ID number on the check. Once the checks and letters are written, they are sent back to the Treasurer for her signature and then sent via certified mail directly to the student's university. |
