In October of 2010, HCDVCC was awarded a grant from the Houston Endowment to allow the organization to focus on building a strategic plan to prevent domestic violence in Harris County and increase coordination and cooperation among service providers. HCDVCC has been working with a volunteer board which has made the work challenging to accomplish. In November, the board hired two full time staff to lead the organization. The staff implemented a plan to conduct a Community Safety Assessment. This plan is an evidence based approach that will allow the organization to develop a diverse team to conduct an assessment of each system that serves victims of domestic violence. This includes, law enforcement, the District Attorney's Office, area Domestic Violence programs, medical service providers, and other social services. Through the course of the assessment the team will identify best practices and gaps in services and implement a coordinated plan to bridge the gaps in services. HCDVCC also facilitates an Adult Fatality Review Team to examine opportunities to bridge gaps to prevent future deaths due to domestic violence. The organization has developed training and outreach programs for the faith community, and it continues to participate in a collaboration that is working to increase screening for domestic violence in pediatric settings across the county.
