Public education videos were enhanced and public service announcements made, increasing the visibility of the spectrum of eosinophil associated disease among the public. Began work on a new website including new content and webinars. Website updates included revision of disease-specific education materials. Began work on a new children's book to be published in 2011. Education materials distributed internationally. Newsletters with educational articles and informational brochures were produced and distributed. Assisted in the report language for NIH study of eosinophil associated diseases and participated on the NIAID Food Allergy Guidelines Coordinating Committee. APFED representatives attended the associated meetings of the NIH and NIAID organizations and other national medical organizations. Advocacy was enhanced by obtaining the services of a consultant to make legislators in Washington, DC aware of the disease and the need for research funding.
