DURING THE YEAR ENDED DECEMBER 31, 2010, THE ORGANIZATION RECEIVED A 500,000 GRANT FROM THE APPALACHIAN REGIONAL COMMISSION TO BE USED ON A PROJECT REFERRED TO AS THE "NORTHERN RING EXPANSION". THIS EXPANSION ADDED A LOOP TO THE FIBER OPTIC BACKBONE LEASED BY THE ORGANIZATION TO A FOR-PROFIT ENTITY NAMED TELEPAK NETWORKS, INC. THE FUNDS WERE USED TO PURCHASE SPECIFIC PIECES OF EQUIPMENT INTEGRAL TO THE OPERATION OF THE LOOP FROM TELEPAK NETWORKS, INC., WHO HAD ALREADY PURCHASED THAT EQUIPMENT IN ANTICIPATION OF SELLING IT TO THE ORGANIZATION. AFTER THE ORGANIZATION PURCHASED THE EQUIPMENT FROM TELEPAK NETWORKS, THE ORGANIZATION EXECUTED A CAPITAL LEASE WITH TELEPAK NETWORKS, LEASING THE REFERENCED EQUIPMENT BACK TO THE FOR PROFIT ENTITY FOR MONTHLY PAYMENTS OVER THE NEXT 10 YEARS AGGREGATING TO 500,000. AFTER DISCOUNTING THE FUTURE LEASE PAYMENTS RECEIVABLE TO PRESENT VALUE, USING A 3.75% DISCOUNT RATE, THIS TRANSACTION RESULTED IN A "LOSS" TO THE ORGANIZATION IN THE CURRENT YEAR WHICH WILL BE RECOVERED THROUGH SUBSEQUENT INTEREST COLLECTIONS ON THE DIRECT-FINANCING CAPITAL LEASE. TELEPAK NETWORKS, INC. OPERATES THE BACKBONE AND "NORTHERN RING" FIBER OPTIC CABLE NETWORK, LEASING THE BACKBONE AND THE EQUIPMENT REFERRED TO ABOVE FROM THE ORGANIZATION.
